- Laytonsville Grove Parcels A & B label as 'Forest Conservation' as Parcel C is
- Label Laytonsville Grove and Len-Mar Park subdivision
- Parcel A at corner of Maple Knoll Dr and 108 used to be Parcel 305? I don't have good notes on this

- Parcel 402 should be C1
- Lots 703 and 665 should remain as R1
- Parcel 295, 244, 195, 189, Parcel D on Maple Knoll- show as Commercial
- Rosser property on Barbeery Lane should be parcel N045 it is labeled as 1
- Rolling Ridge subdivision Historic District ends at lot 4 do not show on Lot 5

- Laytonsville Grove Parcels A & B label as 'Forest Conservation' as Parcel C s
- Label Laytonsville Grove and Len-Mar Park subdivision
- Parcel A at corner of Maple Knoll Dr and 108 used to be Parcel 305? don't have good notes on this

- Lot 2 on 1<sup>st</sup> Street, 715, 745, 744, 769, 770, 662 and 663 should be Historic Institution add new color
- Parcel 402 should be Agriculture
- Laytonsville Grove Parcel E (Sand Trap) & D (Maple Knoll) should show as Institutional
- Parcel 295, 195, 189, 244 show as R2
- Rosser property on Barberry Lane should be parcel N045 it is labeled as 1
- Parcel 181 should show as Institutional
- Fix area shown as Historic District (yellow) to match other maps
- Laytonsville Grove Parcels A & B label as 'Forest Conservation' as Parcel C is
- Label Laytonsville Grove and Len-Mar Park subdivision
- Parcel A at corner of Maple Knoll Dr and 108 used to be Parcel 305? I don't have good notes on this
